Unapproved GENERAL MEETING MINUTES

OLD-BRULE HERITAGE SOCIETY

Middle River Health and Rehabilitation Facility, Town of Hawthorne

October 14, 2009

Old-Brule Heritage Society members welcomed the many residents of the Middle River Health and Rehabilitation Facility who joined them for the program about the history of the facility and for refreshments. Jim Pellman's presentation included information about relevant land transactions beginning in 1874 to the

current time. He also showed many slides of the buildings and site, the staff, and the residents over the years. Tom Perry, who was in attendance along with his wife Helen, provided additional information.

CALL TO ORDER: 1st Vice President Shirley Umolac called the meeting to order at 7:32 p.m.

MINUTES: Alice moved to accept the minutes of the June 19, 2009 general meeting, which were published in the August OBHS Newsletter. Following a second by Earl, the minutes were approved.

TREASURER'S REPORT: Ron reported that as of September 30, 2009, OBHS had a balance of \$ 1,185.01 in its checking account, \$ 4,533.04 in savings, and \$ 5,536.70 in its Certificate of Deposit. These accounts are held at the National Bank of Commerce in Poplar.

Sales receipts for the Festival Weekend totaled \$677.25, compared to about \$1,000 last year. Merchandise sales totaled \$274 (about the same as last year); bakery/donations were \$328.25 (compared to about \$475 last year); and \$45.00 in memberships were collected. This year, fewer pavers were ordered during this weekend. Inclement weather had an effect on attendance and sales. After a motion by Alice and a second by Mary Ann to accept the treasurer's report as presented, it was approved.

OLD BUSINESS:

Davidson Windmill Committee Report:

Sidewalk: 277 pavers have been ordered. More will be coming soon to the site.

Grounds: No more mowing will be done until next year.

Signage: Future project.

Eskolin House: The cupboards are in but need to be cleaned and modified. The plan is to use old-fashioned linoleum for the counter tops. Doors are painted.

Mill Merchandise: The pink hats have all been sold; the sale of vests is moving slowly. Earl has featured a cap in blue on the OBHS website. Shirley and Alice plan to complete a merchandise inventory soon.

Windmill History Booklet: About ten of these were sold during the Festival Weekend.

Next Windmill Committee Meeting: No date is set. Work will commence in the spring.

Fund-Raising Committee Report: OBHS has decided to forgo participation in the Youngers' promotion this year.

Archives Committee: The next meeting will be held on October 26.

Website: Earl reported that he was unable to make changes on the website for a period of three weeks. Microsoft had dropped service to our program, creating a lack of log-on access. Earl contacted Jon Winter and the problem has been resolved. Earl has plans to put more pictures on the website. Thanks, Earl, for your time and creativity in keeping our website easy-to-use, attractive, and current.

Pollari Memorial Gift Committee: Jim reported that Randy Jones is enthusiastic to get going on the project again. It will be a winter project. Randy will be working from Harry's historical map to transfer railroad line information. Logging grades need to be confirmed. The map will be upgraded, including the addition of the Davidson Windmill. Work will resume when Randy is ready.

Publicity/Advertising Committee: Thanks to Ina and Mary Ann for the great job they are doing.

Calendars: In progress. Jim had suggested during the General Meeting in August that we order 250 for the next year.

Membership Committee: Dues collection for 2010 is in progress. Members are reminded to record volunteer hours on the blue forms.

Brule History Group: No report was received. Jim noted that the group is leaning toward having Nan Wisherd publish their work.

Taylor's Bridge: Ron Hendrickson said that two possibilities for getting the sign completed are being explored.

Clarification of Officer Job Description: On hold.

Next Board Meeting: November 11, 6:00 p.m. at the Eskolin House

Next General Meeting: This will be our annual Christmas gathering. Shirley volunteered to do the decorations. It was decided to see if we could meet at the Brule Town Hall. Mary Ann will check with Minerva regarding arrangements.

Other Old Business: Mary Ann noted that there were a few items left from the bake sale, which have been frozen, and brought to this meeting for sale. All prices have been reduced at least 50%. Monies can be given to Ron. Mary Ann reported good attendance for the bake sale.

NEW BUSINESS:

Communication: Many dues have been received. Book orders have been slowly, but steadily coming in. Ron read several thank-you notes. Lois Pollari made a contribution to OBHS from money she received at her 80th birthday celebration. The Wisconsin Association for Home & Community Education (HCE) sent correspondence thanking OBHS for the tour of the windmill and Eskolin House during their recent convention. According to Mary Ann, we received a \$100 donation from this group.

Publications: Jim reported that he is having a copy of Jane Pearson Grimsrud's book printed from the digital file copy that she has provided to enable our group to better assess and appreciate the work. The book is about the early days of Cloverland, her family, and their neighbors.

Audrey Hakkila noted that the Ed Pearson family provided Old-Brule Heritage Society with a booklet about the history of the old Parkland Hospital and other items for the archives. Thank you to the Ed Pearson family for this contribution!

Sympathy and Encouragement: OBHS sends sympathy to the family of Elna Rantala. Elvie A., who was in attendance at the meeting, demonstrated good recovery following her recent surgery.

ADJOURNMENT: Audrey made a motion to adjourn the meeting, which was seconded by Elvie. The meeting was adjourned at 8:00 p.m.

Eskolin House, Town of Lakeside

November 11, 2009

Members Present: President Paul Colby, 2nd Vice-President Harry Wester, Secretary Lila Ronn, Treasurer Ron Hendrickson, Irene Brazill, Karin Colby, Mary Ann Gronquist, Audrey Hakkila, Jim Pellman, Eddie Walman, and Nancy Wiitala.

CALL TO ORDER: President Paul Colby called the meeting to order at 6:10 p.m.

TREASURER'S REPORT: Ron reported the following balances at Poplar National Bank of Commerce effective October 30, 2009:

Checking Account – \$ 1,879.60; Savings Account -- \$ 4,533.81; and Certificate of Deposit -- \$ 5,536.79. Jim moved that the report be approved, followed with a second by Audrey. The motion passed.

MINUTES: Audrey made a motion to approve the minutes of the last Board Meeting held on September 9, 2009, as printed in the OBHS News of October 7, 2009. Audrey moved that these minutes be approved and Mary Ann seconded the motion. The minutes were approved.

OLD BUSINESS:**Davidson Windmill Committee Report:****Grounds:**

Sidewalk -- Paver orders now number 291. Ron recently picked up 21 of the completed ones. Audrey noted that some pavers are not organized together as families wish.

Biffy/Storage Building – Lighting, plumbing, and shelving has been completed. Eddie will check with Don regarding the status of service for this building. If possible, the Board decided that the Biffy be left open during the winter, with no pumping done. Jim suggested some type of antifreeze such as that used in recreational vehicles.

Flagpole -- The flagpole light and a light for the parking lot have been used. Ron noted that a third motion light to illuminate the corner would be desirable.

Eskolin House: Cabinets have been moved into the storage room, but the upper units need to be repositioned six inches higher to allow for use of small appliances on the counter. Ron will be working on this task.

Mill Merchandise: A clothing inventory has been done. The Mill History books have been selling. Five have been consigned at the Northern Lights Bookstore in Canal Park. Jim reported that Barnes & Noble has been contacted. We are already on their website. They have requested that we send one book via UPS to their headquarters in New York. B&N would sell the books for 40% of their cost (\$4.80), leaving 60% of the proceeds for OBHS (\$4.80). Other vendors such as Northern Lights would be offered the same percentage.

Next Mill Committee Meeting: On call.

Insurance: Ron reported that we could drop the personal property coverage that we have with our current insurance carrier, Wilson Mutual. However, our annual premium would remain at \$406 per year. Ron has contacted an agent from State Farm, Matt Thorson, who quoted a policy cost for liability only of \$104 annually. Jim moved that OBHS obtain this policy from State Farm. Harry seconded the motion and it was passed.

Fund-raising Committee: The Wisconsin Arts Board in Superior is offering a Grant Writing workshop in Superior on Thursday, November 19, from 1-4 p.m. Jim reported that the Brule Research Group (Laila, Minerva, and Velma) has expressed an interest in attending. Ron will call Patricia Lenz to pre-register these three participants. Others who are interested in attending should call Ms. Lenz at 715-364-2453. Paul noted that late registrants would be able to attend as well.

Archives Committee: Next meeting is on Monday, November 23. Audrey noted that the Pearson family booklet on the Parkland Health Facility is a great resource. Several board members expressed an interest in reading it.

Pollari Memorial Gift Committee: Randy Jones plans to work on the map during the winter as time permits. He has expressed need for input regarding what is to be excluded. Jim suggested that all main lines and runs of the railroad should be included. Branches could be added later as "non-confirmed". The committee will meet once Randy has completed his work.

Publicity/Advertising: Ina (publicity) and Mary Ann (advertising) continue their outstanding work on this committee.

Publications Committee: As decided at the annual meeting, 250 calendars will be printed for 2010. Jim is working on the production and hopes to have them ready before the holidays. Mailings to businesses for donations for ads have been sent, and ten responses have come in to date. There are OBHS Calendars in inventory for all years from 2006. Jim will contact B & B to get information from this firm for an ad in our 2010 calendar; this action is a follow-up to an earlier decision by the board to recognize the complimentary audit B & B completed for us.

A copy of the Jane Pearson Grimsrud family and Cloverland history is ready to be picked up from Silver-Tonsberg for board review. If we order 10-20 spiral bound books, our cost would be \$22.00 per book. The publication would total 303 pages bound back to back, with a clear vinyl cover and spiral wire binding.

Membership Committee: Audrey has been mailing membership cards as dues continue to come in. Members are reminded to record their volunteer hours.

Brule History Group: Work continues.

Taylor's Bridge: The sign has been completed by Cricket Signs of Superior and was on display in the Eskolin House. It will be mounted into the frame and brought to the bridge site. An identical sign, only smaller in size, is available for use elsewhere.

Clarification of Officer Job Description: On hold.

Next Board Meeting: After a discussion about accessibility to the Eskolin House during the winter, Jim made a motion that OBHS pay \$50.00 to the Town of Lakeside, the current annual fee for driveway snowplowing. After a second by Nancy, the motion was approved. Harry and Jim will be responsible for snow-blowing the sidewalk to the house. The next board meeting will be held on January 13, 2010 at the Eskolin House.

Next General Meeting: The next general meeting will be held at the Brule Town Hall on Wednesday, December 9, 2009 at 6:00 p.m. We will begin with a potluck dinner, followed by a preview of our 2010 calendar by Jim. After the meeting, a Christmas gift exchange will take place. Members interested in participating in this exchange should bring a gift, valued between \$5-10, and labeled as male or female (or both). Shirley will be responsible for decorating.

Board members applauded Jim for his work on the calendar and for all that he does on a regular basis for OBHS.

NEW BUSINESS:

Communications: The New Holstein Historical Society noted in their recent newsletter that they had redone their website to provide linking potential and to allow users access to archive photos. Jim noted that he and Earl reviewed this user-friendly website and consider it a model for OBHS.

Sympathy and Encouragement: Wishes for improved health are sent to Philip Ketola, Darwin McConkie, Howard Hakkila, Marvin Colby, and Denise Dahlen.

Donations: Thanks to Jon Winter for his donation of a letter file and to Jim Pellman for two chairs to be used in the Eskolin House. Jackie Plunkett sent OBHS a packet of photos of our early years, beginning with the very first board meetings. Thank you, Jackie.

News: Members Janine and Doug Seis will be performing in the play "Fort Nebagamon" on November 13. Congratulations to member Patricia Luostari, for whom the new auditorium at NWHS has been named. Congratulations and best wishes to the NWHS football team.

Other New Business: Ron will revisit the process related to having the OBHS property re-zoned to commercial.

ADJOURNMENT: Audrey moved to adjourn the meeting, followed by a second by Jim. The meeting was adjourned at approximately 8:15.

No. 71

The following is the December image and text from our **2009 OBHS History Calendar**.

12. Amnicon Mine, 1900.

From the time of the first Euro-American visitors along the South Shore of Lake Superior in the 1600s the presence of native copper deposits was known, and excited interest. Native American extraction sites became the best evidence for the presence of significant copper amounts, such as those at Copper Creek now in Pattison State Park. Beginning in the 1840s mining was attempted along the Douglas-Brule Range, and later on further south in Douglas County. The deposits in Upper Michigan were well exploited very early, and miners from Michigan's Ontonagon District



were among the very first settlers in Superior in the early 1850s. Expectation was that successful copper mining was almost inevitable in the region. Success proved more difficult than predicted. Limited by the remote conditions and technology of the time, abandoned sites and mines came to dot the higher regions paralleling the lake shore. The Bardons were interested parties in the attempts made around 1900, including exploratory pits right in what is now Amnicon Falls State Park. This may have been activity at those excavations. *(Picture from John McCabe's Superior Annual 1900, photo-copy in OBHS Archives.)*
